



S.N.	CRITERIA	DEPARTMENTAL REQUIREMENTS
1	General	The vehicle shall be a double cab pickup with a right-hand drive model, featuring both two-wheel and four-wheel drive modes . It shall be suitable for driving in on-road conditions, providing smooth and economic performance, as well as in off-road conditions, delivering strong and adequate traction, maneuverability, and stability for safe driving. The vehicle must be capable of handling rough, sandy, slippery, and hilly road conditions in Nepal, operating at altitudes of up to 2500 meters and in ambient temperatures ranging from -3°C to 50°C. The gross vehicle weight shall not be less than 2700 kg, and it shall have a seating capacity for at least five passengers, including the driver.
2	Engine	The vehicle shall be equipped with an engine cooler, developing a rated power output of not less than 60 HP and a torque of not less than 195 Nm at rated RPM, with an engine displacement of range 2350 cc to 2700 cc.
3	Emission Standard	The emission standard of the offered vehicle must comply with or be superior to the applicable standard prescribed by the Nepal Vehicle Mass Emission Standard, and this compliance must be certified by the Department of Transport Management.
4	Gauges	The vehicle shall be fitted with all the necessary gauges, indicators, and signals required for efficient operation, functional monitoring, vehicle performance, and maintenance. This includes, but is not limited to water temperature gauge, fuel gauge and oil pressure gauge with all other standard items provided in the offered vehicle model.
5	Transmission	The vehicle shall have a manual shift transmission with at least five forward gears and one reverse gear , all forward gears being synchromesh. The 4WD system shall be engaged through a control accessible to the driver.
6	Ground Clearance	The vehicle shall have a minimum ground clearance of 190 mm , with higher ground clearance preferred.
7	Suspension	The front and rear suspension shall be of leaf spring.
8	Tyres	Standard Size
9	Steering	Power assisted/Power Steering
10	Brake	The vehicle shall have front disc-type brakes and rear drum-type brakes, all hydraulically operated, along with a parking brake.
11	Clutch Type	Dry Single Plate
12	Turning Radius	Not more than 6.7m.
13	Fuel Tank Capacity	Not less than 50 Liters
14	Cab/Body	The vehicle shall have a 4-door cab, all metallic with an insulated roof, right-hand drive, laminated glass windscreen, wipers, and glass windows on the doors. It shall feature thorough ventilation, comfortable and adjustable seats for both the driver and passenger, two sun visors, two side view mirrors, and a rearview mirror.
15	Chassis and Frame	Steel, heavy duty high rigidity frame structure suitable for rough road conditions.
16	Essential Accessories	<ul style="list-style-type: none"> • Head light, tail and rear light, reversing light and turn signals. • Cabin lights • Speedometer / odometer. • Heavy duty front bumper. • Jack with handle • Mud guard at front and rear • Front seat belt for driver and co-passenger • CD/MP3 Player, Preferably with Radio, MW <p>Equipped with all accessories offered in standard model but not limited to the above items.</p>

17	Instructions	All signs and instructions in the vehicle shall be in English.
18	Manuals	One copy of the Operator's and Owner's Instructions and Maintenance manual in English shall be supplied.
19	Tools	A set of tools, with a tool bag, as required for general maintenance shall be supplied.
20	Color	Standard Color
21	Proven performance	1. The vehicle offered shall have proven performance and be a current model under standard production by the manufacturer for at least one year (Not before 2024 AD.) . 2. The bidder shall provide the manufacturer's data on the performance of the unit, including fuel consumption, and the performance of the engine.
22	Warranty	The vehicle shall be warranted for at least 1,50,000 km or a minimum of one and half year after acceptance.
23	Initial Service	The supplier shall provide with the vehicle all the necessary filters for the first one service, after the vehicle has been commissioned and accepted.
24	Delivery	The Double-cab Pickup, RHD, (4X4), 1 unit, shall be delivered to: Kamalamai Municipality, Sindhuli, Bagmati.

Note:

1. *The major items are indicated by bold and highlighted letters/alphabets/figures in the technical specifications. Non-compliance with these major items will result in non-responsiveness of the bid offered.*
2. *The bidder shall submit a fully completed and signed tender form along with detailed technical specifications of the double-cab pickups being offered, including the brand, model, engine capacity, fuel type, and additional features. Additionally, the submission must include a clear and detailed price schedule outlining the cost per unit and any applicable taxes.*
3. *If the bidder is not the manufacturer, they must provide an authorization letter from the manufacturer permitting them to sell and supply the vehicles. Additionally, the bidder must submit proof of experience in supplying similar vehicles, such as copies of contracts or reference letters, to demonstrate their capability and reliability.*
